- 1. Adoption of Agenda motion to adopt agenda, second. All in favour
- 2. Approval of Previous AGM Meeting Minutes April 11, 2022 motion to adopt minutes, second. All in favour

- 5. President's Report Kelsey Hornung Kicked off with successful 3 on 3. Evaluations for only the u9 team. Colts helped out with evaluations. Successful tournaments, and quad raffle. Looking forward to building the association up for next year. Thank you to the Miller McCoy fund for their support in providing money towards each teams away tournament.
- 6. Treasurer's and Auditor's Report(Paige Murphy) Same time last year we ended with approx. \$28,000. This year we have approx \$20,000 to \$24,000 after all expenses. Added funds to keep the power skating program going for a few more weeks, as well as purchasing development equipment. \$22,000 from 4 tournaments. \$40,000 in registrations. Quad raffle brought in \$8,200. We paid \$4,000 out of pocket plus raffle for player development. Expenses: Paid \$50,000 in ice rentals, \$8,000 in refs. Our association depends on fundraising events to keep the cost down for our members.
- 7. Ice Coordinator's Report (Chad Brander) Will need to book Ice soon for next year. Do we want to keep Sunday ice time? This year we were not able to sell it to fun hockey when we didn't need it. Can we extend the time slot? That would make it more sellable if we did not end up using it. We would rather not give it up and need it in the future. Is the cost this year the same? Or is it going up again? Next year we are hosts of the 2-27 Tournament. Will fun hockey give up that weekend? Can we move that tournament to the weekend after? July is usually when we have to submit our ice time.
- 8. Coach in Chief Report (Rick Phillips) No report.
- **9. Fundraising Report (Cora Lynn Seiler)** Apple sales and the Quad raffles. Sold 258 boxes of apples the most we've ever sold. We sold 642 tickets for the quad raffle. Next year we should try a cash draw rather than raffle and we should try and find something more local than the apples as a lot of that revenue goes into shipping.
- 10. Appointment of Auditor motion to appoint Anderson Slipp as our auditor, second. All in favour
- **11. Lottery Licence Renewal Motion -** Motion to renew the licence, second. All in favour. Fundraising coordinator will renew.
- 12. Review and Accept Bylaw Changes read through changes and updates. Added forms for complaints. Complaint flow chart should be more clear. We should be careful that we aren't putting things into bylaws that should be a policy so it can be changed or adjusted more than just once a year.
